Subject: Regarding strengthening of COVID19 RTPCR (3g) Confirmatory testing by ICMR approved private labs.

As per the "Test-Track and Treat" strategy for control over COVID-19 transmission ICMR approved labs are allowed to perform RTPCR (3g), as per their capacity and allocated or designated districts, in order to provide clarity for distribution of samples, as per the table below:-
